Principal's Report

The Principal's Report was taken as read, with the following highlights:

*Catholic Special Character External Review

Final confirmed report came through – recognition should be made of such a glowing review. Three key recommendations:

- 1. Closer scrutiny of guiding document The Catholic Education of School Age
- 2. Scaffolded strategic Te Reo and Tikanga plan to move the school to the next level
- 3. Working with the parish to support families in the Baptism and sacramental programmes

*Student Achievement on PAT Reading Assessment in Term 1

Reflected the impact 2020 had on our children. What came through in report comparing Term 1 2020 and Term 1 2021 is that the results are almost exactly the same. Children's overall reading over that year (credit to parents and whānau) was positive. Report showed some families were disproportionately affected by the lockdowns.

*Home-school Partnership Plan 2021

- Catholic Special Character looking at those opportunities to strengthen Parish and School relationship.
- Digital technologies sessions for whānau were well attended although many people did not make it to them. – it was well attended but a lot of people did not make it. Repeating this again twice this week.
- Ka Hikitia and Action plan for Pacific Education goals included in the plan.
